NOTIFICATION

Whereas, the Joint Transport Commissioner, Agartala, Tripura vide his letter No. F.21(17)/TC/MISC/2023/7016 dated 26.02.2024 has proposed for imposition of some traffic restrictions in Nagerjala Battala and nearby areas and issuance of Notification in this regard as per decisions taken in the joint meeting of officials of Transport Department, Traffic, AMC, Sub-Divisional Administration, TRTC and various Stake Holders/Organizations/Unions held on 12.01.2024;

AND

Whereas, I, Dr. Vishal Kumar, IAS, District Magistrate, West Tripura District am satisfied that it is necessary to impose restrictions on the movement of vehicles, parking of vehicles, picking up and dropping of passengers by vehicles in Nagerjala Battala and nearby areas in the interest of public safety;

Now, therefore, in exercise of powers conferred upon me under section 115, 116 and 117 of the Motor Vehicles Act, 1988, , I, Dr. Vishal Kumar,IAS, District Magistrate, West Tripura District, do hereby specify the following in the interest of public safety:

- All the commercial vehicles shall be restricted from parking at the Battala stretch. They shall be allowed to park and also picking up and dropping of the passengers inside the Nagerjala Motor Stand only.
- 2. The existing AMC authorized pre-paid parking zones of Battala, TRTC Complex, Below Flyover-bridge and Southern bank of river Howrah shall remain closed for all types of commercial-vehicles-to-avoid-Traffic-Congestion.
- 3. All the passenger carrying vehicles from the southern side towards Nagerjala will pick up and drop their passengers in front of Chowdhury Mill (near Bordwali Filling Station).
- 4. All passenger auto-rickshaws plying towards Amtali, Kathaltali, Ashwini Market, Camper Bazar and AD Nagar can pick up the passengers from Pillar No. 36 (below the flyover bridge) one by one. The sequence of movement of auto rickshaws shall be maintained by Volunteers.
- 5. All auto rickshaws, E-Autos, E-Rickshaws and pedal rickshaws will be parked at the front side of Nagerjala Motorstand.
- 6. All light passenger vehicles should pick up passengers from southern side of Nagerjala Motorstand.
- 7. All buses should pick up passengers from the parking bay at the southern side of Nagerjala Motorstand.
- 8. All other buses for night halt, maintenance and other purpose should be parked on northern and western side inside Nagerjala Motorstand.
- 9. All auto rickshaws, E-Auto and E-Rickshaws plying towards Barjala, Durga Chowmuhani, Gol Chakkar shall pick up passengers from Fire Service-AK Road-Police Headquarter Road.
- 10. Both sides of the Battala-Nagerjala Road is declared as No Parking Zone.

This restriction shall be in force w.e.f. 03.03.2024.

Take notice that the Superintendent of Police,(Traffic) and Superintendent of Police, West Tripura shall enforce this order.
